

Privacy Policy

This Privacy Policy ("Policy") applies to _____, and Form + Finish ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include _____. The Company's website is a Concreting services site. Collection of your Personal Information

- Engage in public or peer-reviewed scientific, historical, or statistical research in the public in
- Enable solely internal uses that are reasonably aligned with your expectations based on your
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with
